- All government fees, taxes, assessments, levies or license fees including hst, mpac are extra
- Gate card deposit (refundable) \$25
- Hydro deposit (refundable) \$100
- NSF charge \$25
- Sale of all trailers in the Park must be approved by the office and is subject to a Value Added Transaction Fee (VATF)
- Trailers older than 15 years will not be accepted into the park. No trailers older than 25 years can be sold on site.
- Proof of 2 million liability insurance coverage for trailer, boat, golf cart/ATV is required.

Value Added Transaction Fee (VATF) at sale of trailer:

- Any trailer sold on a **Regular Site** will be subject to a **\$1,000** VATF
- Any trailer sold on a **Canal or Premium Canal** site will be subject to a **\$2,000** VATF
- Any trailer sold on a **River Site** will be subject to a \$3,000 VATF
- There is no charge for trailers advertised and sold in the Park if they will be leaving the Park

Payment schedule to reserve and lease site for the 2025 season.

- 1<sup>st</sup> deposit payment of \$ 800.00 is due September 15, 2024. Non-refundable
- 2<sup>nd</sup> deposit payment of \$ 800.00 is due January 31, 2025. Non-refundable
- Remaining balance is due Victoria Day Weekend 2025.

Our seasonal site fees should be paid in full at the beginning of the season and there is no refund if you vacate the site before the end of the season. 2% per month charged on all overdue accounts
